

**ORDINANCE NO. 4342**

AN ORDINANCE OF THE CITY OF EDMONDS,  
WASHINGTON, CREATING AN END OF SUMMER RECESS  
FROM THE CITY COUNCIL'S REGULAR MEETING  
SCHEDULE

WHEREAS, the city council has the power to organize and regulate its internal affairs under RCW 35A.11.020; and

WHEREAS, the city council has determined that there should be an end of summer recess from its regular meeting schedule to provide the council, mayor, and staff with a predictable break from city council meetings; NOW, THEREFORE,

THE CITY COUNCIL OF THE CITY OF EDMONDS, WASHINGTON, DO ORDAIN AS FOLLOWS:


Section 1. Subsection A of section 1.04.010 of the Edmonds City Code, entitled "Regular public meeting time and days," is hereby amended to read as follows (new text is shown in underline; deleted text is shown in ~~strike-through~~):

A. Full Council. Regular meetings of the city council shall be held on every Tuesday of every month at 7:00 p.m., except for the second and fifth Tuesdays of any month, the last Tuesday of August, and the first Tuesday of September. ~~at 7:00 p.m.~~ Regular meetings of the city council shall be held as a hybrid meeting that is accessible both virtually and in-person and where the in-person component is conducted in the Council Chambers, Public Safety Complex, 250 Fifth Avenue N., Edmonds, Washington. Council meetings shall adjourn no later than 10:00 p.m. on the day initiated unless such adjournment is extended by an affirmative vote of a majority of the council as a whole plus one.

Section 2. Severability. If any section, subsection, clause, sentence, or phrase of this ordinance should be held invalid or unconstitutional, such decision shall not affect the validity of the remaining portions of this ordinance.

Section 3. Effective Date. This ordinance, being an exercise of a power specifically delegated to the City legislative body, is not subject to referendum and shall take effect five (5) days after passage and publication of an approved summary thereof consisting of the title.

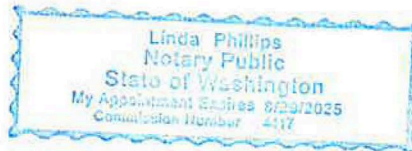
